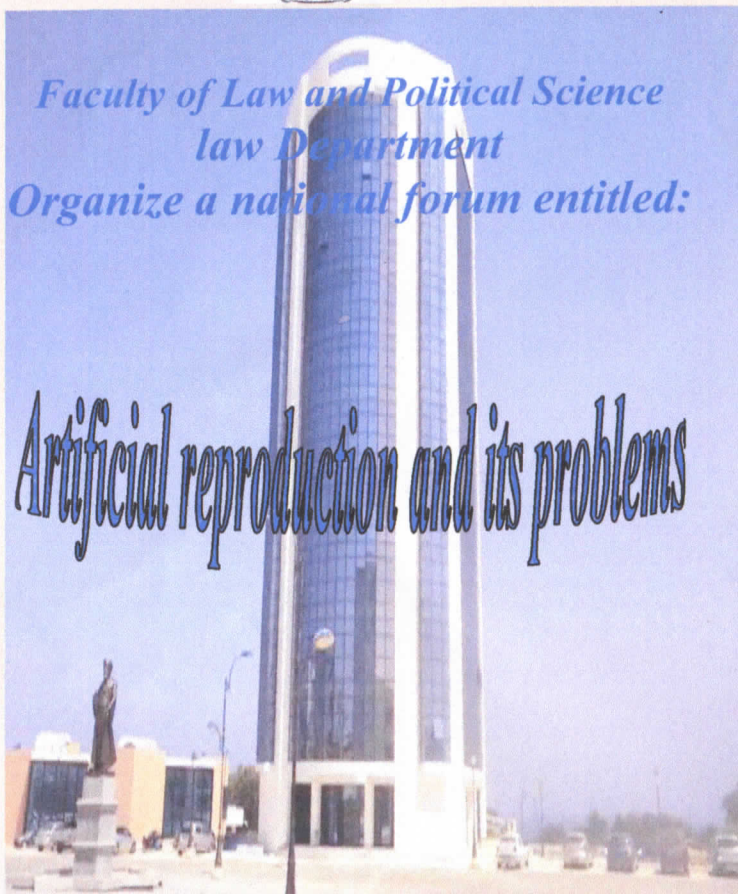

### **Introducing the forum:**

Recent scientific discoveries are considered a reflection of the contemporary knowledge revolution, which has a great impact on many fields, including the field of health, especially the field of reproduction. As its role has become more positive as it is a means of assisting in procreation and achieving hope in obtaining children, the joy of life, however, some people make it an alternative means to sexual desire, so they benefit from it without limits, and here the role of legislation and its necessity to organize and put penalties against exceeding these limits appears, through this forum, we try to discuss the reality of these discoveries and their aspirations, and we also address the reality of the legal legislation in this field and the extent of its awareness of this matter and its role in controlling the various practices related to this process. It is also an opportunity to know the role of Islamic law in guiding these laws and their ability to address such issues. Therefore, the problem of the forum is about the possibility of controlling the reproductive process in the light of contemporary scientific progress, and what is the importance of legal controls and the mechanisms for achieving them in reality?

### **Forum objectives:**

Through this forum, we hope to achieve the following objectives:

- 1- Discussing the reality of artificial reproduction in Algeria and other countries and comparing them.
- 2- Addressing the reality of legislation in keeping up with developments through health laws, family laws, penal laws.... and all related laws.
- 3- Calling for the establishment of deterrent legal mechanisms to keep pace with this development and control it.
- 4- Studying the rules of Islamic law and explaining its role in controlling such various developments.

### **Themes of the forum:**

We are trying to address the issue through the following themes:

**The first theme:** Defining the developments taking place in the field of artificial fertilization and the extent to which Algeria has been affected by this (types of artificial reproduction, its legal ruling...).

**The second theme:** Knowledge of contemporary problems and the location of laws and their role in controlling the reproductive process. (Different internal legislation and its relationship to the subject, international legislation,... Islamic legislation...)

**The third theme:** Knowing the different effects of this process and the resulting problems. (How to adjust the use of extra embryos and eggs, embryo banks, controlling the sex of the fetus and the number of embryos..., social effects).

**The fourth theme:** Trying to develop legal solutions to take advantage of these discoveries and propose a methodology and control plan.

- 1- The research should be included within the axes of the forum.**
- 2- The research should be original and adopt the scientific methodology in writing research.**
- 3- The number of research pages should not be less than 15 pages and not more than 20 pages.**
- 4- Interventions should be written in Arabic. Interventions in foreign languages should be accepted, provided that they are attached to a summary in Arabic.**
- 5- The research is written in Simplified Arabic font, size 14 in the text, and size 12 in the margin.**
