The forum preamble

Economic crimes of our time occupy great importance; It is one of the most important characteristics of the twentieth century being civilized crimes dependent on the state system; Perhaps the most prominent example of these crimes is customs crimes that occupy a great place in the scope of criminal legislation due to their peculiarities.

It is no secret to anyone the seriousness of these crimes, and if the actions that constitute them varied, they are all in violation of the law and economic financial systems of the economic; Rather, it has the greatest impact on the criminal policy followed by the customs legislator and the legal interest that he wanted to protect, and the problem lies in the difficulty of researching it because of its technical nature, as well as its own significance in understanding the purpose of the legislator from the texts in light of the stages of the development of customs law and its characteristics of instability as a result. Because he knows multiple fluctuations,

so that it is difficult to keep pace with, for this we find that the Algerian legislator in customs matters is dealing with crimes. With various common rules in public law, these rules are highlighted in the Customs Law No. 17-04 and the Anti-Smuggling Law No. 05-06, and in the context of this privacy we mean in particular the criminal legal issues that draw attention from the scientific and practical point of view, in the forefront of which is the subject of the material pillar and the moral corner. In the establishment of customs crime, which some considered a material crime that does not require moral pillar, as well as another important legal issue related to the procedures for customs crime are followed by the procedures and methods stipulated in an exceptional basis in the Customs Law, despite the public means available to detect it.

Other questions also arise about textual measures to confront customs crimes and understand the purpose of the legislator from the two mentioned texts, especially in the law.
